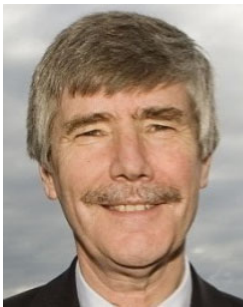


Mr Paul KOFFEL (Chair)
